1788: Danforth was granted 250 acres of land on May 8th, 1788, and was what was then purchased by the State in 1920 to be part of the State College of Forestry.

Built first sawmill on Butternut Creek in Manlius (Dewitt)

1792: March 3rd, 1792, Militia was formed in Onondaga Territory, two battalions. The first was commanded by Major Moses DEWITT and Major Asa DANFORTH, with captains Hezekiah OLCOTT, Asa DANFORTH, Jr. and Josiah BUCK.

1794: First Court was held at the Danforth home, May 1794.

There was a mural painting hung in the "new" courthouse in July 1906 which depicts Danforth with his wife and two children paddling a barge. The painting, by William De Leftwich Dodge of New York hangs on the north side of the lobby nearest the street. This is one of four canvasses that depict historical and legendary events in the city's history, and are located on the second floor.

"Asa Danforth served as lieutenant in Captain Peter Harwood's company, Col. Ebenezer Learned's regiment at Bunker Hill, and in the battle were thirteen kinsmen. He commanded a company in Col. James Converse's Worcester county regiment, 1777, to reinforce Gates in the Burgoyne campaign. He was born at Worcester, 1746, and died in Onondaga Valley, N.Y., 1818."

Danforth was described in 1794 by Upper Canada's first lieutenant governor, John Graves Simcoe as "the most virulent enemy of Great Britain in that Country." It was surprising that his son Asa would appear before that same government a couple of years later seeking a contract to build his road from Toronto to Prince Edward County.

Asa Danforth Sr. left a will in 1819 that states:

"I give and bequeath to my beloved wife Hannah Danforth all my real and personal property during her natural life and after her death I give the same to my son Adams Danforth and I do here by nominate and appoint Poleski King executor of this my last will and Testament."

It would be customary to leave property to an eldest son, but there is no mention of any "Adams Danforth" in Massachusetts birth records, or in grave records for the family. I have been unable to locate an "Adam/Adams DANFORTH" in any of the 1800 - 1900 US censuses, or US Death records.

"Onondaga History to be Honored by Monuments"

"The boulder in memory of Asa Danforth is a fine specimen of Labrador granite, brought here during the glacier period, and has been placed in permanent position near Stop 8 on the Rockwell Springs road, where the "Indian

Trail" crossed Salina st. A bronze tablet will also be inserted in this boulder, indicating the former home of Mayor Asa Danforth, (about 40 rods west), no marked by a flag staff."

The D.A.R. had an active group, the General Asa Danforth Chapter in Syracuse.

John also moved to the Onondaga Valley and was instrumental in setting up salt production in Liverpool, New York in 1793. These salt springs around Onondaga Lake were the first known sources of salt away from the sea within the United States.

DANFORTH, ASA, colonizer and road builder; b. 29 June 1768 in Brookfield, Mass., son of Asa Danforth and Hannah Wheeler; m. there in 1789 Olive Langdon, and they had three daughters; d. in or after 1821.

Asa Danforth Sr moved with his family to New York's Onondaga valley in 1788. Asa Danforth Jr returned to his birthplace the following year to marry and shortly afterwards settled with his bride at Salt Point, later Salina (Syracuse), N.Y., where he manufactured salt. His father was a prominent figure in the Onondaga area and was described in 1794 by Upper Canada's first lieutenant governor, John Graves Simcoe\*, as "the most virulent enemy of Great Britain in that Country." Thus, it was somewhat surprising when young Danforth appeared in the province in 1797 seeking the favours of government.

In 1792 Simcoe had initiated a policy of entrusting whole townships to the exclusive control of colonizers in the hope of promoting rapid settlement. There apparently was a misunderstanding as to the benefits promised to the township promoters; they seem to have thought they had been promised an outright grant of their townships if they succeeded in establishing a certain number of new settlers. In fact they were only entitled to 1,200 acres of land and the right to settle people where they pleased. In any case, it soon became evident that the scheme was a failure. In May 1796 Simcoe proclaimed many of these townships forfeited for lack of settlement, and declared that those who claimed to have settled their townships must submit their proofs to the Executive Council on or before 1 June 1797. Danforth was, as he put it, "connected . . . in Settling" the townships of Haldimand, Hamilton, Percy, and Cramahe, and to demonstrate that the proprietors' obligations had been met in these townships he appeared before the council in 1797 to ask that some 205 settlers there be confirmed in possession of their lots.

Simcoe's successor, President Peter Russell\*, had a more conciliatory approach to the proprietors than Simcoe. Thus, in July 1797 the unforfeited townships were reopened but the proprietors, Danforth included, were allowed 1,200 acres each if they became residents of the province. The council's decision fostered a good deal of discontent and under the leadership of William Berczy\*, one of the most disappointed of the proprietors, caveats were being filed contesting the council's right to grant lands previously entrusted to proprietors. To protect their claims to the four townships, Danforth and his associates directed their attorney, William Weekes\*, to join in filing caveats. Outraged, the council dismissed this action as "most improper and unfounded" and rescinded its recommendation that Danforth be granted 1,200 acres personally. Early in 1799 Danforth apologized, explaining that he was bound to people in the United States "to use every exertion that might be made" and that no "disrespect" had been intended. His apology was accepted and the council restored his personal grants. His problems, however, were not at an end. In 1798 two settlers who had been part of the colonization of the four townships complained to the council that Danforth's name, rather than their own, had been entered against the lots which they had settled and

improved. The council ordered an investigation and on the basis of the subsequent report (tabled in 1799) Danforth and his associates were accused of fraud and duplicity. As a result, all previous confirmations of lots in these townships were suspended; no new warrants for land were issued until 1 July 1800 and then only upon proof of actual improvement.

It is somewhat surprising therefore that, while this investigation was proceeding, the council on Russell's recommendation had contracted on 9 April 1799 with Danforth to open a road from York (Toronto) to the mouth of the Trent River. With causeways and bridges it was to be completed by 1 July 1800. Danforth was to be paid portions of what was owed him as the road progressed and was inspected, the balance upon completion. He did not receive his payments promptly, and was hampered by a shortage of capital. During a brief absence in the United States in March 1800, he was jailed as a debtor. Released, he returned to Upper Canada in May, sought and was allowed an extension, and completed the road on 18 December.

The council was not satisfied with his work. He received a partial payment but was told no further payments would be made until the road was properly finished. A bitter Danforth returned briefly to the United States where the pressure from his creditors had not abated. He claimed to have had several conversations with presidential candidate Aaron Burr. Danforth anticipated that a Republican triumph in the election would "afford something handsome to those who were dragged from home by fair promises of Genl. Simcoe and the like . . . when the Executive Council saw that our Americans had made choice of the best lands in the Province they laid a plan to recind & take away the Lands theretofore granted and placed their own locations on the same." Danforth believed that Upper Canadian officials feared the likelihood of the eclipse of British power in North America but that "three-fourths of the common people would be happy of a Change." Back in the province in June 1801 he was hopeful of a favourable settlement on his claims for land and money. Disappointed yet again he left the province for good in January 1802.

Before departing Danforth laid plans for a meeting in Albany, N.Y., of disgruntled Upper Canadians. Among those he wished to include were Joseph Brant [Thayendanegea\*], Ebenezer Allan\*, and Silvester Tiffany\*. The purpose was the overthrow of the provincial government. Several meetings apparently took place but nothing came of the plan. As late as 1806 Danforth saw a possibility for recovering land and money. In this instance Weekes's successful attack on Lieutenant Governor Peter Hunter\*'s handling of public money was the source of his hope.

Danforth spent some years at Salina working his salt leases, constantly hampered by lack of capital and forced to borrow to finance necessary improvements. In 1811 he leased his salt privileges and equipment to his principal creditor, who eventually acquired out-right ownership of the property as well. Last notice of Danforth dates from 1821. He was in New York City hiding from the sheriff. The road for which he is famous fared little better. Official reports of October 1802 were highly critical. Deficient from the outset, within a few years it had deteriorated and was largely unused.

His marriage to Olive Langdon was recorded in Fonda. Montgomery County, a small village on the Mohawk River that would have been on the family's route to Onondaga County from Massachusetts.

Asa Danforth, Jr. arrived in Onondaga County in the spring of 1788 following his father Asa Danforth, Sr., who had built his home and barn on the road from Onondaga Castle to Salt Point (later named Salina). Danforth Sr. had been persuaded to relocate to the area by Ephraim Webster from Mayfield, Montgomery County.

After receiving permission from the federal government in May 1788, Asa Danforth, Jr, along with Comfort Tyler drove across the country with the livestock, while his father and his wife (Hannah Wheeler) made the journey with their goods and farming tools arrived via two flat-bottomed bateaux through the portage at Rome, through Oneida Lake, around by the Seneca River to Onondaga Lake, and landed at the mouth of Onondaga Creek. There they

met up with his son Asa, Ephraim Webster and Comfort Tyler who had arrived previously with all the livestock. Moving up the creek, they made the first settlement south of Onondaga Hollow on May 23, 1788.

1800 - 10: Family enumerated in Onondaga County, New York.

JAN 1802: Left Ontario and returned to New York States where he worked his salt leases near Syracuse.

More than a dozen letters from Asa Danforth, Jr. to Timothy Green deal with commerce and industry around Lake Onondaga. The subjects under discussion include salt mining, land speculation and road building in the decade following 1797. At one time, Green seems to have been hounding Danforth for a disputed debt of more than \$100,000. An unusually testy letter by Danforth reveals that he was in jail, and he then proceeds to lash out at Green, who apparently had a hand in his confinement.

The most important papers in the legal and financial section concern land sales between 1774 and 1840. The transactions dealt with extensive tracts in Connecticut, New York and Georgia. A recurring name in the documents is Asa Danforth, and the transactions often concern the development of the salt industry around Lake Onondaga. Aaron Burr is also mentioned on a few promissory notes. One document bears the signature of Timothy Green and DeWitt Clinton; it is an agreement of 1795 relating to 100,000 acres south of Lake Ontario. Another transaction, dated 1797, released 24,000 acres of land in Franklin County, Ga.

#### REUBEN PATTERSON FAMILY

The early settlement of Sandusky township, Sandusky county, was not so rapid as that of the eastern part of the county, because the land was more low and wet, the timber more dense, and the air more full of malaria, which caused fever and ague. Such was the condition of the country when Reuben Patterson and his wife, Eunice (Danforth) Patterson, and family, in the fall of 1816, came in wagons from the State of New York to the wilds of Ohio. They located first at Huron, in Erie county, which was then the stopping place of many western immigrants. The following spring they removed to the Peninsula, in Ottawa county, but here sickness so afflicted them that their new home with improvements had to be abandoned. In the spring of 1818 they moved to Lower Sandusky, and found temporary shelter in a small log house in the old fort, which had been used during the war of 1812-13 by U. S. military officers. Comforts and conveniences were out of the question, and the floor of the house was made of clay. There was but one bedstead, in a corner, and during the day all the clothing was piled upon it. At night the beds for eight persons were made mostly on the bare ground. One gate of the fort served as a part of the floor. Mr. Patterson and his sons during the winter cleared a piece of land on the west side of the river, and in the spring of 1819 the family moved into the log cabin they had constructed on this place, which is known as the Whittaker Reserve, in Sandusky township. In the meantime his eldest daughter, Eveline, taught school in one of the block houses of the fort, having some Indian as well as white children under her care. About the year 1821-22 Mrs. Eunice Patterson, being well provided with purchase money, mounted her horse and, in company with Lysander C. Ball and James Whittaker, traveled through the wilderness, one hundred miles, to attend the government sales of public lands at Delaware, Ohio. She there bought the tract which became their homestead, and it has for many years been known as the Patterson Farm, on the east side of the Sandusky river, just north of Fremont. The incidents of this heroic trip were often related by her to her grandchildren. She was remarkably determined and courageous in business matters, but kind and generous to a fault in her home.

The children of Reuben and Eunice Patterson were: (1) Sear Patterson, who retained his residence in the State of New York. (2) Alvord Patterson, who married Miss Julia Webb, in New York State, and subsequently came to Lower Sandusky, where he died; their children were—Eveline Patterson, who married John Shannon, and died at Fremont in 1893; William Patterson, now married and lived in South Dakota; Fanny Patterson, who married, lived and died in Iowa; Cordelia Patterson, who died in childhood at Lower Sandusky. (3) Eveline Patterson, married to Lysander C. Ball. (4) Danforth Patterson, who married Miss Sarah Perry, and for a number of years lived on the Patterson farm, where each passed away, leaving no children. (5) Harriet Patterson, married to James Moore, (6) Julius Patterson, married to Miss Margaret Leary, by whom he had eight sons and two daughters- Robert C, Danforth, Rodolphus D., Sardis B., John P., Rawson, Oscar, Charles M., Sarah and Juliette. Julius Patterson was for many years a successful farmer, also a contractor on public works. He led an honest and temperate life. He was born May 17, 1808, and died at his residence in Fremont May 23, 1887. (7) Caroline Patterson died at the age of twelve years from the effects of a fall on the ice in the river, which she crossed in attending school. The death of Reuben Patterson occurred June 1, 1840, at Lower Sandusky, and that of his wife, Eunice Patterson, December 17, 1839, the latter at the age of sixty-five years. Mrs. Eunice Patterson was a daughter of Gen. Asa Danforth, who was born July 6, 1746, at Worcester,

Mass.; he entered military life at fourteen years of age, served in the war of the Revolution, was at the battle of Lexington, and distinguished himself by many brave and patriotic achievements. He was one of the first to begin the manufacture of salt at Onondaga, N. Y. He died September 2. 1818, at the age of seventy-three.

The subject of this sketch was born in Rockingham, Vermont, March 26, 1795. His father, Eusebius Ball, a native of Massachusetts, served in the war of 1812, and died in the State of New York at about the age of sixty years. When eighteen years old, Lysander C. Ball went to Trenton Falls, New York, where he learned the trade of blacksmithing. At twenty-three, he moved to Boston, Massachusetts and soon after started westward for Detroit, on foot, arriving

at Lower Sandusky (Fremont), Ohio, in April, 1818. He saw but one house on the present site of Cleveland when he came through there, and on reaching the Sandusky river there was no way of crossing it but in little Indian bark canoes. At Fremont there were but three or four log cabins, and very little enterprise, yet he found employment with Thomas L. Hawkins, who owned a good pair of oxen, and Mr. Ball, being very skillful in the management of them, helped to build the first dam across the Sandusky river, his compensation for one month's labor being a pair of shoes.

The roads westward through the old "Black Swamp," as it was then called, being perfectly impassable at the time, Mr. Ball was persuaded to establish himself in business at Fremont, and like many others with small means took "Hobson's choice." He placed his little blacksmith shop on ground now occupied by State street, between the Croghan House Block and Buckland's corner. Mr. Ball was married, February 23, 1823, to Miss Eveline Patterson, daughter of Reuben and Eunice (Danforth) Patterson, and took up his residence in a log cabin adjoining the back part of what is now "Croghan House" lot. In this cabin two children were born to them, the first dying in infancy. He afterward built and for many years occupied a residence and shop on Front street, north of the Wheeling depot, which property was in later years purchased by the Wheeling & Lake Erie Railroad Company. In 1853 he moved thence to a farm north of the city, but adjoining the corporation, where he continued to reside until his death, which occurred March 21, 1877, when he was at the age of eighty-two years. His residence was on high ground overlooking a bend in the river from which the scenery is delightful. Being a lover of the beauties of natural scenery, he employed his sound, well-balanced mind and his industrious hands in working a magical change in his home surroundings.

In the life and character of Mr. Ball, the virtues of industry, temperance, frugality, truth and integrity, order and peace, were conspicuously displayed. A model husband and father, a good and generous neighbor, carried away by no excitement, misled by no shams or false appearances, loving his home and family so that except on duty he was seldom away from it, he led that peaceful and complete life which entitles him to a lasting and honored remembrance.
